

## What this document is for

To give advice about the best ways to provide housing and support services for people with a learning disability.



To look at how this is done already and make it better. For example, to make sure people come first and can make choices about what they need to lead good lives.

### Supported living

A lot of people with a learning disability live in supported accommodation. For example, it may be in a house with 3 or 4 other people where support workers help with day to day living.

We think this has been a good thing. But we must make sure people's needs and choices are put first.

To help people think about these important issues we have written 12 questions with answers.

1. What services should be given to people?

Support to have a good life.













#### 2. How will this happen?



By making sure people come first and we work together.



#### 3. What must services try to achieve?



Make sure people are given their rights.

Make sure they look after people's well-being.



Make sure people can be independent.



4. What type of housing should people be able to have?



Ordinary houses or flats in the community.



5. What is the best housing and support like?




A person has their own home.



A person can choose who supports them.

Support and housing are given by different organisations.

The person will normally have a **tenancy**.

#### 7. What rules should be followed for housing?



The **Reach standards**. These are a list of things to help make sure people who have support have their choices and rights protected.



7. What does good support look like?



The person is put first.



Questions 8 and 9 ask about how we plan and make sure good support is provided.



People who plan and deliver support services should work together with the people being supported and their families.



10. How do we make sure housing and support services are provided for people with a lot of needs?



By different organisations working together to make sure people are supported well.



11. How will we know that people's well-being is improving?



By looking at the difference housing and support services make to people's lives.



12. How can we make sure housing and support services can last a long time?



Make sure we keep checking that we are spending money for services well.



Put on a workshop to look at the best ways of providing housing and support services and the differences they make.

Find ways to check how support and housing services are helping people.



Make a toolkit that will help plan how much housing and support costs.



Look at how **Assistive Technology** can help people. This is using equipment to help people be more independent.
