#### 1. Welcome and introduction



Karen said she would help Sophie to lead the meeting. Professor Meena Upadhyaya might help in the future.



Sophie welcomed everyone. She asked people to say their names and who they worked for.



Karen said Claire Hough has moved job. Claire helped make the Improving Lives Programme happen. We thanked Claire for all her hard work.



Karen said Natalie Hughes-Owen had joined the Improving Lives team. They will hire someone to take over Claire's job.



Sophie read out the rules for our meetings. And asked everyone to listen to and respect each other.



She also spoke about the **Learning Disability Programme Group's** rules. She asked if we would like to use these rules too.

# 2. What happened at the last meeting



Lots of members want time in our meetings to talk about things that are not on the agenda. So if something important happens we can talk about it.



For example the Panorama TV programme about hospital abuse. We will call this part of the meeting **Any Other Business**.



Members would also like to know about events. They would like to get this information in a newsletter or an e-mail.

## 3. Improving Lives Programme



Before the meeting you were sent a report about the **Improving Lives programme**. This was the second report about the programme.

Karen spoke about the main things in the report including:



#### Making health fair for everyone

Health boards are getting more money to make their learning disability teams better. And to make their **hospital liaison nurses** better.





Adverse Childhood Experiences means bad things that happen when you are young. For example, if your parents take drugs or if you are abused. We usually call them ACEs for short.



The ACE Hub had a meeting with the Improving Lives team. They talked about how the ACE Hub can help with Improving Lives work.



We talked about the **Believe in Every Child** event that happened in March.



And about how people who work in schools should learn how to deal with problems without using **restrictive practices**.



Restrictive practices are when people try to control your behaviour by stopping you from doing things. It can be things like holding you down. Or putting you in a room alone.



Karen said that the **Task and Finish group** on restrictive practices had planned a meeting for July 15th.



#### **Actions**

You can tell your ideas for lowering restrictive practices to Dermot McChrystal. He will share ideas with the **Association of Directors of Education**.



Karen will add talking about what **Improving Lives** says about health to the agenda for our next meeting.



Dan Jones told us about the **Integrated Care Fund Capital Programme**. This programme gives money to:

- social services projects
- o health projects
- o housing projects.



Dan said more people now know how important good housing is for people's health and well-being.



The programme is giving away £105 million over the next 3 years. Most of this money will go to:



- o people with a learning disability
- o carers
- o older people
- o children who need extra support.



**Regional Partnership Boards** will apply for this money. They can use information from their **population assessments** to help them decide how to use the money.

We talked about:



- o how this money is being spent
- new housing for people with learning disabilities
- and who is in charge of making sure the projects are running properly.



#### **Actions**

 Alyson will send us links to the population assessments so we can read them.



 Alyson will also ask people from the Integrated Care Fund Capital Programme to come to our meeting in September.

We will ask them to give a presentation. And we will have the chance to talk about any issues.

### 4. Transition services



The Welsh Government wrote a paper about their policies to help young people transition to adult services. This paper was sent to us before the meeting.



**Transition** means changing from being a child to an adult. It means changing from children's social services to adult social services.



Jon Williams talked about a new piece of work to help young people transition to adult health services.



This work should make sure that children and young people get the right health services at the right time.

June 17

The first meeting for this will be on June 17.



Jon said they would stop using the word transition. Because it is often used to talk about people changing their gender. It could be confusing. Instead, they would use the word handover.



Most members were not happy with the word **handover**. Because it sounds like the young person's choices are being handed over to professionals.



They thought that people understood that transition meant the journey from childhood to adulthood.



Jane Rodgers, Julie Heal and Wendy Parry spoke about how transition happens in Monmouthshire. They talked about what worked well and what did not.



They said that transition was a hard and scary time for families. Some families were afraid of things like:

Losing support



 Having to start new relationships with new support workers



 Realising that their child is becoming an adult. And that the law is different for adults.



 Realising that the way of deciding who gets Continuing Health Care is very different for children and adults.



Members said that transition could be better if different services put their money together.



They said that services would need to work together to make this happen. And that they would need a clear plan.



Members also thought that people who get Continuing Health Care should get direct payments.



Emma Curtis said members should look at the recommendations in the 'Don't Hold Back' report. This was a report about transition. It was written by the Children's Commissioner for Wales.

the research before.



We wondered if the group could start again. Or if we could keep all the research in 1 place.

Karen said that the Research group would look at the results of Edward Oloidi's research.

Karen said she would meet the:






These are parts of Welsh Government that do research.

Professor Upadhyaya said more work needs to be done to find out what causes learning disabilities. She said we need to know this to meet people's needs better.



Karen said that the **Learning Disability Improving Lives programme** was started because services need to be better for people with Learning Disabilities.

# 6. Independent enquiry into Child Sexual Abuse

# 7. Any Other Business



We were very worried about the **Panorama Programme: Undercover Hospital Abuse Scandal**. This programme was about abuse at Whorlton Hall hospital.



We wanted to know how we can be sure this kind of abuse was not happening in Wales. Or to Welsh people in hospitals outside Wales.



Hazel Powell said that there is a piece of work being done. It will look at care placements outside Wales and see if they meet people's needs.



Joe Powell said there are lots of types of abuse. Sometimes it is physical and sometimes it is people's attitudes. He said we need to change our culture to make sure we treat people with learning disabilities with respect.
