The **Stolen Lives Campaign Group** wrote this document. It is an easy read version of '**Stolen Lives Manifesto**'.


About us

We are joined by people, groups and organisations who support us.


What we want



We want the **Welsh Government** to:



1. Tell us how many people with a learning disability and autistic people are in hospitals.



2. Explain how you will bring children and young people closer to home and out of these places.



3. Listen to us and understand what families go through.



4. See that sectioning people is not the answer just because services fail to meet their needs.

Sectioning means making you stay in hospital whether you agree to it or not. It uses a law called the Mental Health Act.



5. Work with us and people with a learning disability and autistic people to make support better.

More about what we want

1. Tell us how many people with a learning disability and autistic people are staying in hospitals.



We do not have enough clear information about this.



We want there to be a **National Learning Disability Observatory**. This would be a place to collect and share better information about people with learning disabilities.

2. Explain how you will bring children and young people closer to home and out of these places.



There is no clear plan for making these things happen.



In 2020 there was a review called **Improving Care, Improving Lives**. This looked into people with a learning disability in these hospitals.



It had ideas about what needs to change but did not say how or when.



We think money could be better used to help people to be at home.

3. Listen to us and understand what families go through.



We worry social services and health boards will not listen to us. We want them to treat us better.



Sometimes we do not tell them how bad things are or how much we are hurting. We do not think they understand.



We want them to take better notes when they make decisions about our children. We want to see these notes.



We want to see and talk to our children more. We want you to hear us and treat us fairly.



We think our children should get legal help when they need it.

Doctors and services must follow the law. The Government must do more to check they are.



People should get the right support. They should not be kept in a place that is not right for them.
