

## What is the Medical Examiner Service



We look into all deaths that have not been investigated by a **coroner**.



A **coroner** is a type of judge who **investigates** some deaths. For example, if a death was unusual, violent or sudden.



The **Medical Examiner Service** is made up of **Medical Examiners** and **Medical Examiner Officers**.





**Medical examiners** are experienced doctors. They have special training to **scrutinise** how someone died. And what happened before their death.



**Scrutinise** means to carefully and thoroughly examine the details and circumstances of a death.



**Medical Examiner Officers** support Medical Examiners. They oversee each case. And gather all the information needed to **scrutinise** a death.



We are **independent**. We do not work for the people who provided the care for the person who died.



### We **scrutinise** deaths to:



Check the care people were given before they died.
And see if there is anything care providers need to change or improve.



 Tell care providers or the coroner about things that may need to be investigated further.



Make sure the information in the **Medical Certificate of Cause of Death** is correct. This is a legal document that says someone has died.



 Support the families of people who have died. We can explain the cause of death. And give families the chance to ask questions.



All deaths are **scrutinised** in the same way. There are 3 parts to our work:



We look at medical records.



• We talk to the doctor in charge of the person's care before they died.



• We talk to the families of the people who died.



Listening to you is an important part of our work. We want to make sure you have the chance to talk about anything that has worried you about your loved one's death.



If we need to, we will pass on your concerns for further investigation.

# Will funeral plans take longer



There should not be any delays.



We will work with you to make sure you can carry on with your funeral plans.



The **Medical Certificate of Cause of Death** may take a little longer. But not more than 1 or 2 days.



You can still book appointments with funeral directors and the Register Office at this time.



# Can someone else talk to us for you



Yes. We may contact you to find out who you would like us to talk to instead.



Or you can let the medical team know who you want us to contact.



We will usually contact you by phone. Before we send the **Medical Certificate of Cause of Death** to the register office.



We can contact you in a different way if you prefer. Please let us know.



## What will we ask you



We will tell you what is written on the **Medical** Certificate of Cause of Death.



We will ask you if you have any questions or concerns about the certificate.



We will talk to you about our **scrutiny** into the death of your loved one.



We will ask if you have any questions or concerns about your loved one's death.





We may ask you about what your loved one did for work. To check if it had anything to do with their death.



You can ask any questions you wish about the death. And talk to us about anything that has worried you in any way.



# If you do not want to speak to us about your concerns



We strongly advise that you talk to us about any concerns you have over:

- · your loved one's death,
- or the care they had before they died.



We are here to listen to you.



We can make sure services know about any problems so they can improve.





We may be able to make you feel better about your concerns, by talking things through with you.



We are independent. We do not work for the people who provided the care for your loved one.



So you can be as open and honest with us as you wish.



# What to do if you have concerns about our decisions or work



If you are not happy with our decision, please tell the **Medical Examiner Officer** who contacts you.



They can ask another **Medical Examiner** to look at your case, if needed.



If you are still not happy, we may refer the case to the **coroner**.

We will reply to you within 30 days.
